GIVING YOUR SUPER TO THE BIG BANKS

Changes to industry superannuation proposed by the Turnbull Government will mean less money and more exploitation for working people.

Industry super performs consistently better than commercial funds and creates tens of thousands of jobs every year through investment construction.

Turnbull's laws take power away from working people and hand it to the big banks, who cannot be trusted.

Banks have been forced to pay out \$480 million to customers who were victims of misconduct, are accused of money laundering and the CBA is being investigated for breaching terrorism financing laws.

New laws would gut that safety net and lead to chaos for employers who will need to find more expensive options for training, OH&S and other support for their workforce.

Turnbull's laws won't apply to big business. If applied to the Commonwealth Bank, they would be placed in administration after hundreds of allegations of fraud and consumer rip offs.

The only people who should decide who can lead a union should be the members of that union.
