## WILL YOU GET A WAGE RISE ON 1 JULY?



**If your boss hasn't got a 'Notice of Employee Representational Rights' document to you by now, there is no guarantee you can get a pay rise by 1 July.**

Don't just sit there – talk to your boss now. If you haven't got a representational rights notice, ask them why - it's time to get on with it!

July 1 is approaching fast and if the process isn't followed there may be no 5% increase!

# CHINA DEAL EXPOSED

**The Abbott/Turnbull Government stuffed up the China Free Trade (CHAFTA) deal.**

Chinese workers are being flown to Australia, given falsified health and safety accreditation and being made to work long hours for \$70-\$75 a day, 6 days a week. This is exactly the kind of

exploitation Australian unions warned of when the Liberals rammed it through Parliament.

It's time to end the exploitation. Australians are already losing jobs thanks to the Liberal Party's CHAFTA stuff-up. Australian and Chinese companies are importing

workers to work for less than the minimum wage, without penalty rates or WorkCover. They don't even pay income tax.
